We are setting a climate and safety goal and that committee will be developing a stakeholder survey. Mrs. Luedtke provided technology updates. Brooke completed a Marzano review with staff. Then we split into elementary and JH/HS. The elementary got an update on Social Studies standards and discussed the requirements at the elementary level for the Americanism Bill. We also discussed the process of adopting science curriculum/alignment with standards for next year. The JH/HS staff completed an activity in supporting students academically at the JH/HS level. This is School Board Appreciation week. We want to thank you all for your service and providing our students, staff and school with amazing opportunities. Last week was School Counselor week. We would like to take the time to recognize Ms. Oelsligle for her work with our students and her continued efforts to provide support and guidance for our students.
